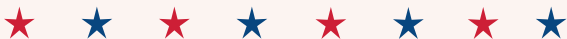

## VOTER INFORMATION

**Eligibility:** You are eligible to vote if you are a citizen of the United States, at least 18 years of age by Election Day, and a legal resident of Washington State. *If you have been convicted of a felony, your right to vote is restored as long as you are not under the authority of the Department of Corrections. Once your right is restored you must re-register in order to receive a ballot.*

**How to register:** If you have a Washington State Driver License or ID card, you may register online at [myvote.wa.gov](http://myvote.wa.gov). Or, you may register with the Department of Motor Vehicles when applying for or renewing your WA Driver License. Otherwise, registration forms are available at the Auditor's Office in the Whatcom County Courthouse, at city halls, fire stations, public libraries, and post offices.

### 2023 Election Dates:

<i>Special Election</i>	February 14, 2023
<i>Special Election</i>	April 25, 2023
<i>Primary Election</i>	August 1, 2023
<i>General Election</i>	November 7, 2023

*Federal, state, and some county officials are elected in even years; city, county, and district officials in odd years. State ballot issues are submitted to the voters at the General Election.*

**Vote by mail:** Washington State is a vote-by-mail state. After registering, your voter registration with your precinct number will be mailed to you. Ballots are mailed 20 days before Election Day. You may return your ballot by mail or deposit it postage-free in an official ballot dropbox.
